I hereby declare that the information given above is true and correct to the best of my knowledge and belief. The licensee will return the licence to the CCE for cancellation or amendment (subject to the cancellation status) within 7 days beginning on the date of cessation. I further understand that under section 41(4) of the Anti-Money Laundering and Counter-Terrorist Financing Ordinance (AMLO), a licensee who, without reasonable excuse, fails to comply with this requirement commits an offence and is liable on conviction to a fine of \$50,000.
