ANTI-MONEY LAUNDERING AND COUNTER-TERRORIST FINANCING ORDINANCE (Chapter 615)

Contravention	 Contravention of section 2(1) of Schedule 2 to the AMLO, namely, the Licensee has failed to take measures to verify the identity of its customers and their beneficial owners. Contravention of section 19(1) of Schedule 2 to the AMLO, namely, the Licensee has failed to establish and
	maintain effective procedures for determining whether a customer or a beneficial owner of a customer is a politically exposed person.
	(3) Contravention of section 23 of Schedule 2 to the AMLO, namely, the Licensee has failed to take all reasonable measures to ensure that proper safeguards exist to prevent a contravention of any requirement under Part 2 or 3 of Schedule 2; and to mitigate money laundering and terrorist financing risks.

Disciplinary Action Taken	Public reprimand and imposition of a pecuniary penalty of HK\$16,000.
