**Circular to Money Service Operators
Anti-Money Laundering / Counter-Terrorist Financing**

(1) United Nations Sanctions (Haiti) Regulation

Further to our circular issued on 9 July 2025, an updated list specifying “individuals and entities” under section 27 of the United Nations Sanctions (Haiti) Regulation (Cap.537CO) was published on the website of the Commerce and Economic Development Bureau (“CEDB”) on 22 October 2025. (3) United Nations (Anti-Terrorism Measures) Ordinance

Further to our circular issued on 17 October 2025, an updated list specifying terrorists and terrorist associates designated by the UNSC will be published under section 4 of the United Nations (Anti-Terrorism Measures) Ordinance (“the UNATMO”) (Cap. 575) ^{Note¹} in the Gazette.

Money Service Operators (“MSOs”) are reminded to refer to Chapter 6 of the Guideline on Anti-Money Laundering and Counter-Financing of Terrorism (For MSOs) which contains guidance on the appropriate measures that MSOs should take to ensure compliance with the regulations made under the

MSOs are also reminded to report any transactions or relationships they have or have had with any designated person or entity to the Joint Financial Intelligence Unit.
